The Identified Official with Authority will authorize user access to State of Minnesota Education secure systems in accordance with the user's assigned job duties, and will revoke that user's access when it is no longer needed to perform their job duties. The Director recommends the Board authorize Jim Guetter, Superintendent, RLCCandRLFsupt@gvtel.com, and EDIAM user ID-jguetter to act as the Identified Official with Authority (IOwA) for ISD 630, Red Lake Falls Public Schools.
